Policy implementation to promote the journey of self-resilience

- Accelerating the development and adoption of a sound child online protection strategy and comprehensive action plans for governments
- Improving online safety measures and tools for industry in the Least Developed and Developing Countries

Capacity development to scale up train the trainer programs

- Build capacity by running self-paced programs for 'Train the Trainers' modules providing a framework and leveraging on partner organizations, with the aim to empower local children and parents
- Develop open source solutions to make digital content, information and skills available to children, teachers, and administrators
